Prior to Meeting

Webinar Attendees

As an attendee of a webinar, you are privy to view the hosts audio and video stream, the screen the host may choose to share, and any panelists audio and video stream. As an attendee, you will not have any video stream displayed in the webinar. As well, your audio stream is disabled by default, though you may be put on the Allow to Speak status if necessary (i.e. nominating a representative). If you have any questions during the webinar, you are welcome to utilize the integrated Q&A functionality during the webinar session. As well, you have the Zoom chat available where you can send messages to the host, to the host and the panelists, or to everyone participating in the webinar. The most critical feature is the Raise Hand functionality, which the host can see when you activate this status.

Nominations

At a certain point during the AGM, we will be asking for nominations for our Board of Directors. Prior to this, the host will lower all hands of attendees. Then, if you wish to nominate an elected official appointed as representative of a First Nation, you can raise your hand in Zoom. The host will then activate the Allow to Speak status, and through your audio stream you may nominate someone. We subsequently activate the Allow to Speak status for the nominee to verify the acceptance of the nomination and to give a 2-minute speech. Voting for the Chair and Deputy Chair positions will occur directly after their respective nominations if there are two or more nominees.

Voting

If the amount of nominations is greater than the number of directors allowed on our board, we will then perform a vote per nomination. Much like the nominations, the host will lower all hands of the attendees. We will then proceed through the list of nominations, calling on the attendees to cast a vote in favour by using the Raise Hand functionality. We will attribute for any vote that may be representing multiple proxies and tally them together. Once complete, we will announce the results of the votes.
